This year Comparative Orthopaedics Day is dedicated to honoring those serving in the medical branches of our armed forces, and we are so honored to have two keynote speakers: Dr. Philip J. Belmont Jr., Professor, Department of Surgery with Uniformed Service Health Sciences School of Medicine, and program director of the orthopaedic surgery residency program with the William Beaumont Army Medical Center/Texas Tech University Health Science Center in El Paso. Additionally, Colonel Belmont has served as the orthopaedic surgery consultant to the U.S. Army Surgeon General since 2013. He served as an orthopaedic surgeon with the 228th Combat Support Hospital in Iraq.

Also featured is Dr. James T. Giles III. Dr. Giles serves as chief of the Animal Health Branch with the Department of Veterinary Sciences at the Army Medical Department Center and School in Fort Sam Houston, Texas. He recently served as the senior veterinary surgeon in Afghanistan, providing medical support to military working dogs in a combat theater.
