Four new CRC Tests are on the horizon

Three criteria for a CRC screening blood test that can be covered by Medicare and Medicaid once every 3 years must fullfil the following for CRC:

1) ≥74% sensitivity, 2) ≥90% specificity, and 3) FDA approval.

Sensitivity: among patients with cancer, how many will be detected by the test; high sensitivity means true positives Specificity: among patients without cancer, how many will test negative; high specificity means few false positives
